Subject:- Grant of conditional permission to Shri Hingulambika Education Society's Ayurvedic Medical College, Hospital & Research Centre, Bhavsar Nagar, Sedam Road, Gulbarga-585106, Karnataka with 60 seats in UG (BAMS) course for academic session 2019-20 in compliance of Judgement dt. 30.09.2021 passed by Hon'ble High Court of Karnataka, Kalaburagi bench in WP No. 201728/2021 and in reference of letter received from Ministry of AYUSH vide ref. no. L-14014/267/2019-EP-1 dated 13.12.2021 -reg.

Sir/Madam,

I am directed to refer to the Ministry's order of even no. L-14014/267/2019-EP(1) dated 06.07.2019 & 12.11.2020 vide which denied permission under Section 13C/13A of the IMCC Act, 1970 was conveyed to the said college to take admission for 60 seats in UG (BAMS) course with for the A.Y. 2019-2020 due to not fulfilling of the basic requirement as per sub-Regulation 3 of Regulation 3 of RMS-2016 for granting conditional permission for 60 seats in UG (BAMS) Course for the Academic session 2019-2020.

In view of above decision, college has challenged the denial order for the A.Y. 2019-2020 and approached before the Hon'ble High Court of Karnataka at Kalaburagi Bench, and filed writ petition no. 201728 of 2021 against the denied permission dated 12.11.2020 for Undergraduate (BAMS) Course for the A.Y. 2019-2020.

Hon'ble High court vide its order dated 30.09.2021 disposed of the writ petition no. 201728 of 2021 and held as under:-

"In that view of the matter, the Writ petition is allowed. The respondent no.1 is directed to grant permission to the petitioner no. 2 for the academic year 2019-2022 under section 13 C of the IMCC ACT, 1970. It is however, open to the respondent no. 1 and 2 to conduct fresh inspection. If they are of the opinion that deficiencies still persist in the petitioner no. 2, the same shall be compiled by the petitioners within a period of one month from the date of being notified of such deficiencies".

Further, Medical Assessment and Rating Board is also in receipt of letter from M/O AYUSH vide ref. no L-14014/267/2019-EP-1 dated 13.12.2021 forwarding the order dated. 30.09.2021 passed by Hon'ble High Court of Karnataka, Kalaburagi Bench in WP No. 201728/2021 for grant of permission to the **Shri Hingulambika Education Society's Ayurvedic Medical College, Hospital & Research Centre, Bhavsar Nagar, Sedam Road, Gulbarga-585106, Karnataka with 60 seats** for the A.Y. 2019-2020 in compliance of Court Order.

Therefore, as mentioned above, the college has been examined in compliance of above said order passed by the Hon'ble High Court of Karnataka at Kalaburagi in WP No. 201728/2021(EDN-REG). and after examination it has been decided by the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM) to issue **grant of Conditional permission to Shri Hingulambika Education Society's Ayurvedic Medical College, Hospital & Research Centre, Bhavsar Nagar, Sedam Road, Gulbarga-585106, Karnataka with 60 seats in UG (BAMS) course** for the Academic Session 2019-2020.

The earlier order of Ministry's letter No. L-14014/267/2019-EP(1) dated 12.11.2020 stands withdrawn as per the aforesaid court order.
